### **PROCESSING**

Mix ratio	Parts by weight	
RenLam <sup>®</sup> LW 5157	100	
Ren <sup>®</sup> HY 5159	11	

Mix the two components thoroughly in the ratio indicated, then impregnate each layer of cloth as it is laid up to construct the laminate.

Post-curing will improve final properties.

#### After cure: Curing

Pre-cure parts for 48 hours at 25°C, or for 8 hours at 60°C before demoulding, which should be carried out at room temperature.

Commence the post cure of the demoulded part at a temperature no higher than that of the pre-cure. Raise the temperature of the oven by no more than 10°C per hour, until the part has reached 120°C. For optimum heat resistance hold the part for 14 hours at 120°C

#### **STORAGE**

Provided that RenLam<sup>®</sup> LY 5157 and Ren<sup>®</sup> HY 5159 are stored in a dry place in their original, properly closed containers at the storage temperatures mentioned in the MSDS they will have the shelf lives indicated on the labels. Partly emptied containers should be closed immediately after use.

The product should be used when in the temperature range 18-25oC.
